Dear Comrades,

As it was intimated through our earlier Circular after the Secretariat meeting held on 23<sup>rd</sup> October, 2016 decided that the members of ITEF all over the country will **organise agitation programme** in front of offices of all Pr. CCsIT and in front of office of the Pr.DGIT (HRD) to protest against the inordinate delay and the reluctant attitude of the authorities in resolving long pending and some burning issues. Accordingly we have submitted two letters to the Chairman on pending issues and requesting for an early meeting. We informed **the Chairman, CBDT on 17<sup>th</sup> November, 2016 that members of Income Tax Employees Federation all over the country will organize Dharna and Demonstration on 25<sup>th</sup> November, 2016 (Friday) from 11 AM to 2 PM in front of the office of Pr.DGIT(HRD) CBDT and in front of the office of all Pr.CCsIT to protest against the inordinate delay and the reluctant/negative attitude of the authorities in resolving the long pending issues.**

We have submitted three letters to newly appointed Chairman, CBDT for an early appointment for discuss and resolve the issues. But unfortunately the Chairman is not ready to meet us. The copies of the letters submitted to the Chairman, CBDT, by the ITEF in this regard are attached herewith. All Circles of ITEF are requested to submit the letter dated 17<sup>th</sup> & 23<sup>rd</sup> November, 2016 to the respective Pr. CCsIT as intimation to the program with the pending issues of the Circles. The Resolution to be adopted from the meeting on 25<sup>th</sup> November 2016 also attached herewith which is to be submitted to the respective Pr.CCsIT by the Circles after the Demonstration with a request to forward the same to the Chairman, CBDT, immediately and one copy to be sent to the ITEF CHQ. If there is any development or any communication receives from the CBDT, we will intimate immediately. All are requested to organize the programme successfully to show our united strength before the Authority.
